**LETTER OF ACCESS FOR THE PURPOSES OF ARTICLE 95(1) OF REGULATION (EU) 528/2012**

I hereby declare that Aqualution have the right to grant the above-mentioned access to the data in the complete substance dossier.



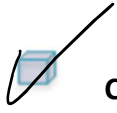
