INSTRUCTIONS FOR USE

HOW TO USE:

FAST ACTION ROUNDUP has a rapid action, with effects visible within 12 hours of spraying.

DO NOT disturb weeds for 7 days after treatment.

DO NOT spray if rain is likely within 30 minutes.

SITUATION	WEEDS CONTROLLED	HOW TO APPLY
Driveways, along fences & lawn edges & prior to planting new lawns or garden beds. Also for spot treatment of weeds in garden beds, rockeries & lawns.	Many weeds & grasses eg: Couch, Dandelion, Flatweed, Kikuya, Nutgrass, Paspalum, Ryegrass, Oxalis & Bamboo.	Apply when weeds are actively growing. Spray to wet all leaves. Weeds may be removed & /or planting may occur in treated areas 7 days after treatment. Perennial weeds may need a repeat treatment.

CAUTION:
